I, the undersigned consent, with reference to Section 29(2) of the Danish Public Administration Act (Act No 571 of 19 December 1985), to the police authority, at the request of the Danish Enterprise and Construction Authority, carrying out a search on my criminal record pursuant to Section 43, no 2 of the Ministry of Justice's regulations for the central criminal register and issuing a report on whether or not there are any obstacles to my admission into the real estate agent register.

Enclose the following with the application:

- 1) proof of the applicant's nationality;
- 2) attestations of professional competence or evidence of formal qualifications giving access to pursue the profession of real estate agent, cf. Sections 9 and 10;
- 3) attestation of the applicant's relevant professional experience where applicable;
- 4) attestation of security pledged, cf. Section 8(3) of the Act on the sale of real estate;
- 5) attestation that the applicant is not prohibited from pursuing the profession of real estate agent in the country in which the applicant was established at the time of application or the applicant's country of origin, even temporarily;
- 6) attestation that the applicant has not, in their position or otherwise in their profession, displayed such behaviour that there is reason to assume that the profession will not be exercised in a reasonable manner;
- 7) attestation that the applicant is not subject to an administration order or entered into bankruptcy proceedings under equivalent rules applicable in the country of establishment;
- 8) attestation that the applicant is of legal age, not under guardianship, co-guardianship or legal restrictions with regard to entering into contracts or managing their own estate under equivalent rules applicable in the country of establishment;
- 9) attestation that the applicant is not indebted to the State for a sum exceeding DKK 50,000.
